## **Technical Standards: Medical Assistant Program**

Specific essential abilities or technical standards have been identified by the Department of Medical Assisting, in accordance with Section 504 of the Rehabilitation Act of 1973 and the 2009 Americans with Disabilities Act Amendment (ADAAA). These technical standards include all of the nonacademic abilities essential for the delivery of safe, effective patient care. These standards are designed to establish performance expectations that will enable students to deliver safe, effective care during clinical practice activities, with or without reasonable accommodations. Qualified applicants and students are expected to meet all admission criteria, as well as these technical standards with or without reasonable accommodations and to maintain related satisfactory demonstration of these standards for progression through the program. The Department of Medical Assisting is committed to enabling students with identified disabilities by reasonable means or accommodations to complete academic and experiential learning required for completion of all degree programs.

Therefore, any applicant or student who seeks accommodation at the time of admission or at any time during progression in the program will be evaluated and receive an assessment of the types of reasonable accommodation(s) needed for the clinical practice component of the program.

The technical standards that have been identified as necessary to meet Medical Assistint program requirements include, but are not necessarily limited to the following:

- a. Possess communication skills sufficient for interaction with others in both verbal and written forms in the Native English language.
- b. Possess physical abilities adequate enough to stand and move around exam room tables/chairs, be able to stretch, bend, lunge, or squat, as needed.
- c. Stand upright and on your feet as needed throughout the course of the day.
- d. Lift and carry a minimum of 25 pounds across a room.
- e. Move and manipulate exam room equipment such as tables, wheelchairs, and exam room carts.
- f. Assemble medical examination/procedural equipment, large and small as requested.
- g. Pass medical instruments quickly and efficiently (i.e. speculums, otoscopes, blood pressure cuffs/meters, EKG machines and oxygen/intravenous equipment/tubing.
- h. Assist in positioning of patients which involves lifting of extremities and trunk.
- i. Assist with prep of patients which involves elevation of extremities as needed.
- j. Assist with transfer and transport of patients.
- k. Demonstrate manual dexterity.
- I. Be able to freely move about the exam room with efficiency, speed, and accuracy.
- m. Be emotionally and physically stable to function in a sometimes-high stress environment.
